2024 - CFN TERMS, CONDITIONS, AND RESPONSIBILITIES

TOUR DEPOSIT, PRICE AND PRICE INCREASES

- Your tour reservation will be confirmed upon receipt of your \$500 deposit, and signed Registration Form is required to hold your reservation for group travel. If you are paying by check, your deposit payment must be received in our office within 10 business days to avoid cancellation. The balance it due 90 days prior to departure. CFN accepts all major credit cards.
- All prices quoted are in US dollars and based on double occupancy in a room. It is also based on a specific number of participants traveling together in the group and on air and land rates in effect at the time of printing and are subject to change.
- In addition, you may be subject to a price increase after payment in full has been received due to potential government imposed taxes and fee. Final payment is due 90 days before departure.
- In case of human or computer error, Christ For The Nations, Inc. reserves the right to re-invoice for the correct price or service. All tips and gratuities are covered in the cost of the tour. Voluntary "Love Offerings" for tour guide and bus driver can be extra and appreciated by their service.
- Rates are per person in US dollars and based on double occupancy in a room. In case of human or computer error, Christ For The Nations, Inc. reserves the right to re-invoice for the correct price or service.

AIR TICKETS AND AIRLINES TRANSPORTATION FROM DALLAS-FT. WORTH INTERNATIONAL AIRPORT

- Roundtrip flights will originate from Dallas/Ft. Worth International Airport. The airfare included in the tour price is based upon the *Super Advance Purchased Excursion fare in effect at the time of the printing and is subject to change*. The tariff governing this airfare contains conditions and restrictions on its use. Once "printed," airline tickets cannot be changed or refunded thereafter. Air tickets: Cancellations and refunds are governed by the tariff applying to the airfare and/or other tariffs of the airlines concerned. Airfare is non-refundable once ticketed.
- Passengers are responsible to ensure that Christ For The Nations, Inc. has the correctly spelled names for air ticket reservations. Due to newly introduced security measures, any name change including minor spelling corrections may require airline reservations to be canceled and rebooked.

- Names printed on the E-Ticket must exactly match the first, middle and last name written in the passport. Christ For The Nations, Inc. will not be responsible for the denial of services by a carrier due to any name discrepancy.
- Subsequent name corrections will be subject to availability at the time of rebooking fee up to \$400 per ticket. Your tour documents including: paper air tickets or E-Tickets receipts, tour confirmation voucher and all other related information will be sent approximately two to three weeks prior to departure provided full payment has been received.
- Post Office Box numbers cannot be used for delivery of travel documents. Please provide street address. (see Registration Form)

LAND PACKAGE ONLY

- Land Package Only: If you choose "Land Package Only", you are responsible for your own air travel to and from Israel. In addition, you will be responsible to arrange your own private transportation to join the tour group in transit or at the hotel location. You can take a local taxi to your destination. Taxis are expensive and will run around \$150 US from airport to hotel to the hotel in Israel.
- If you choose the "Land Package Only" options, you are responsible for your own air travel to and from the Israel and The 7-Day Greek Island Cruise on Royal Caribbean Cruise Ship "Odyssey of the Sea." In addition, you will be responsible to arrange your own private transportation to join the tour at our departure for the cruise. You can take a local taxi from the airport to the departure port and ship dock. Taxis are expensive about \$170-\$200 for each way or take the train for about \$20 US or shuttle for about \$25 US.

BAGGAGE

- Transatlantic flights allow one (1) checked baggage per person in economy class with a maximum travel **weight of 50 lbs**. and luggage dimensions of 62 linear inches. (1) Carry-on bag with a maximum travel **weight of 17 lbs**. and luggage dimensions of 9" x 14" x 22". Airline baggage fees will apply for extra bags and overweight bags.
- Please make sure you label your luggage with your current information and place inside of your luggage an extra itinerary of the tour and the name of the travel company for Israel is SAR El Tours.
- One personal bag (backpack, purse or similar)

- For lost or delayed luggage, the passenger is responsible for notifying the airline directly at the airport at the "Lost Baggage Claim" desk. *Make sure to place an itinerary* in your baggage in case it becomes lost. The itinerary will have the names of the hotels and your tour company, so your luggage can be delivered to you while in Israel
- You can purchase a luggage tracker for around \$40 U.S. on the web. This is a very neat device and could come in very handy in case your luggage is misplaced by the airlines. Because this could happen, keep your medications and carry an extra set of clothes in your carry-on bag.

HOTEL ACCOMMODATIONS

CFNI and its subagents reserve the right to substitute hotels for the same category when necessary.

- Hotels are provided on the basis of two person sharing a room with private bath.
- **Single Room:** A limited number of single rooms are available at a supplement of \$1657.
 - A tour participant must pay this supplement when he/she is the sole occupant of assigned accommodation. Please note the term "single" refers to a person traveling alone and not as reference to marital status. If you would like to room by yourself or have more than two people in a room, check with the tour coordinator for prices.
- **Shared Room:** If a roommate is requested and one cannot be confirmed prior to the tour, the tour participant must pay the single supplement in order to receive final documents. If CFN-Tour succeeds in finding a roommate, but one of the parties intending to share the room should cancel, the remaining party must pay the single room supplement. CFNI is not responsible for roommate assignments that do not work out.

- There are no requirements for PCR tests before or after arriving in Israel.
- Additionally, there are no requirements to quarantine upon arrival in Israel and no COVID testing is required to re-enter the United States.

TRIP CANCELLATOIN INSURANCE - TRAVEL PROTECTION

- Travel insurance is not included in the tour of the price.
- Christ For The Nations strongly recommends the purchase of comprehensive travel insurance package, which covers health, lost luggage, trip cancellation and trip interruption.
- Please note that we cannot accept responsibility for any losses or expenses, which you or any member of your party may incur as a result of failing to secure adequate coverage.
- Please note all cancellations or changes must be sent in writing to Christ For The Nations/Israel via email to cfnitours@cfni.org. *Christ For The Nations, Inc., reserves the right to cancel any listed tour for lack of participation.

PHYSICAL REQUIREMENTS AND SPECIAL ASSISTANCE

- All passengers registering for the tour/s accept the responsibility for being in good health and able to walk, move around by themselves, climb stairs without assistance, walk at a moderate pace on cobblestone streets and uneven ground on a daily basis, and are able to handle their luggage on the tour.
- Because many of the sites are not accessible to the physically challenged, those needing oxygen, wheelchairs, or other ambulatory assistance will find the tour extremely limiting to their experiences. The level of activity for this tour ranges from moderate to strenuous, daily, and the pace is moderate to fast.
- Any physical limitations, health conditions or disability, requiring special attention, should be reported to the CFN tour coordinator, Marianne Allen at marianne.allen@cfni.org at the time the reservation is made.

PROOF OF CITIZENSHIP

- A valid passport is required for all passengers, including children.
- A "passport card" is NOT valid for this tour.
- Travel outside of the United States requires a "traditional passport book" that is valid at least six months following your entry date to your travel destination.
- For U. S. citizens and residents, more information is available online at www.travel.state.gov/passport or by calling the National Passport Information Center at 877-487-2778. No visa is required for entrance to Israel for U.S. citizens.
- Non-U.S. citizens and U.S. citizens originating from outside the U.S. should consult their country's embassy regarding specific requirements for entry into each and every country of destination.
- Your passport name must match the name on your reservation and airline ticket or you may be denied travel. It is the personal responsibility of each passenger to fully comply with all immigration and documentations requirements. For more specific visa requirements, please contact the relevant consulate for your updated information.
- Christ For The Nations is not responsible to provide any travel documents to any of our destinations, including documentation/visas required to enter these countries. It is the personal responsibility of each passenger to fully comply with all immigration and documentation requirements.

DOCUMENTS

- Your tour documents including; paper tickets or E Tickets receipts, tour confirmation voucher and all other related information will be sent approximately two to three weeks prior to departure provided full payment has been received.
- Post Office Box numbers cannot be used for delivery of travel documents. Please provide a complete street address.

TOUR ITINERARY

AIRPORT SECURITY LEAVING THE USA

• Security checks are routinely carried out for your protection and safety. Expect to be asked about the contents of your luggage – whether you packed your bags yourself and were they in a supervised place before reaching the airport. Do not take any mail, packages or unknown items from anyone before or after arriving at the airport.

ISRAEL'S BORDER PROCEDURES - PASSPORT CONTROL

 Upon arrival to Israel, visitors need to present their passports and airline ticket.

TOURIST VISA

• Upon entering the country, you will be given a Tourist Visa. **Put this inside your passport**. If you prefer not to have your passport stamped when entering Israel, make sure you hang on to the small piece of paper stamped by the border agent instead. You will need it when departing the country.

ISRAEL CUSTOMS UPON ARRIVAL

A dual-channel customs clearance system operates in all Israeli airports and at the Rafah Terminal – Israel's southern border crossing. Visitors without any Goods to Declare may pass through the Green Channel upon exiting the Arrivals Hall. Passengers bringing in new commercial products, even if exempt from duty, must declare them and use the Red Channel. For further information please contact The Department of Customs: www.mof.gov.il

ARRIVAL AND HOTEL TRANSFERS

Our tour company in Israel is **SAR El Tours**, and their representative will meet the team immediately after passport control upon your arrival at Ben Gurion International Airport in Israel. He or she will lead the group to the bus where our guide and driver will be waiting for you.

ISRAEL TO ROME CUSTOMS UPON ARRIVAL

Our team will exit the plane and follow directions to passport control. You will see the electronic Kiosk's where you scan your passport, then have your passport stamped and continue to the baggage area. Our transportation is a 5 to 10-minute walk to board either the train, shuttle or taxi. The travel time to the port city is 1-hour. Transportation will be provided to the hotel.
